IMF to discuss \$7 billion bailout for Pakistan in August

Soon Limes Correspondent Islamabad The International Monetary Fund (IMF) Executive Board is expected to convene in mid-August to discuss the \$7 billion bailout package for Pakistan. A staff-level agreement between Pakistan and the IMF was reached on July 12. Sources inside the Ministry of Finance indicate that the IMF board is expected to give its final approval within four to six weeks following the staff-level agreement. However, they added that Pakistan must secure external financing assurances before the board meeting.

Discussions on funding to address climate change and natural disaster risks are anticipated soon.

The IMF has indicated consideration of Pakistan's proposed request for climate financing.

Sources further disclosed that Pakistan must identify long-term priority projects related to climate change.

The IMF's Resilience and Sustainability Facility (RSF) programme offers affordable, long-term financing.

To achieve these goals, Pakistan will need to collaborate with other global institutions, according to the Ministry of Finance.

Privatization and Board of Investment Abdul Aleem Khan has directed the National Highway Authority (NHA) to setup priorities for the construction of highways and identification of new projects. He observed that there would be no compromise on the quality of construction of highways and roads so Chairman NHA should depute honest and competent officers for the projects. Chairing a high-level meeting of the NHA here Thursday, the federal minister said that the real problem was the funds as just spending money was not a miracle so the Government departments have to take steps to raise their income. He further said that the officers of the NHA should take advantage of their abilities and expertise to develop a model of working on projects in other countries as well so that the annual income of the Authority could be increased. northern region, Abdul Aleem Khan said that the construction of the Gilgit-Khunjrab Motorway could prove to be a game changer by providing access to China and Central Asian States, similarly land connectivity through road and rail up to Gwadar is of very important. The 69th birthday President Asif Ali Zardari of the Islamic Republic of Pakistan is being celebrated today. This is the best opportunity to recognize his services for the stability of Pakistan, its democracy, and the well-being of its people, and to pay tribute to his historic achievements One of Asif Ali Zardari's great achievements is that, after the martyrdom of Mrs. Benazir Bhutto, he worked tirelessly for the survival and continuity of the Pakistan People's Party in very difficult circumstances. After the judicial killing of Shaheed Zulfiqar Ali Bhutto, the terrorists' aim in martyring Ms. Benazir Bhutto w to destroy the People's Party. The People's Party transformed the democratic struggle of the people of Pakistan into a powerful political movement in the 1960s and continues to lead this democratic struggle. Shaheed Zulfigar Ali Bhutto himself drafted the party's 'fundamental document at its establishment in 1967, with its chapter dedicated reconciliation. It is important to reference Asif Ali Zardari's historic speech in the National Assembly, where he stated that the era of divisive politics must end, and that we should not pass on a legacy of hate to future generations. Through his conciliatory approach, Asif Ali Zardari introduced prudence, tolerance, and politeness into politics, nurturing great traditions that will serve as a model for genuine political forces.In the political history of Pakistan, the name of Asif Ali Zardari will remain prominent among those great politicians who endured the hardships of long imprisonment. He was imprisoned for 11 years, facing numerous false

Pakistan faces many social, political, and economic problems. it's important to look at the historical reasons for its failures as a state Much of the blame goes to the early leaders, especially Muhammad Ali Jinnah and the Muslim League, who didn't have a clear plan for the new nation. Creating a state based on "Muslim identity" instead of shared culture, language, and values has turned out to be a big mistake. A nation can't be built just on religious identity. Nations are stronger when they share culture, language, and values. The state's attempt to impose a monolithic national identity based on religion has alienated various ethnic groups, weakening national cohesion and leading to internal conflicts. This thing make split between East and West Pakistan. which led to the creation of Bangladesh in 1971, shows this clearly, The big cultural and language differences between Bengalis and West Pakistanis were overlooked in favour of religious identity, causing alienation and

According to Dr. Ishtiaq Ahmad the identity crisis within Pakistan, stemming from its diverse ethnic, linguistic, and cultural composition. state's failure to foster an inclusive national identity has resulted in ethnic tensions and separatist movements."The early leadership under Jinnah and the Muslim League lacked a clear vision of how to govern the newly formed state. It contains everything that matters to a man from morning to night" "The Muslims demand Pakistan, where they could rule according to their own code of life and according to their own cultural growth, traditions and Islamic laws."At an other time, He said Who am I to give you a constitution? The prophet of Islam had given us a constitution 1,300 ago. We have to simply follow and implement it, and based on it we have to establish in our state Islam's great system of governanc

While on the other hand, He said in 1947, during their speech, You are free; you are free to go to your temples, you are free to go to your mosques or to any other place worship in this State of Pakistan. You may belong to any religion or cast or creed that has nothing to do with the business of the State. We are starting with this fundamental principle: that we are all citizens and equal citizens of one State, Now, I think we should keep that in front of us as our ideal and you will find that in course of time Hindus would cease to be Hindus and Muslims would cease to be Muslims, not in the religious sense because that is the personal faith of each individual, but in the State."It is hard to understand what Jinnah actually wanted for Pakistan whether he think a secular democratic state or a religious state. His speeches make it difficult to interpret Pakistan's identity.Jinnah's approach during the independence ovement was to use Islamic identity as a unifying different ethnic groups in Muslims but that his ultimate vision for Pakistan's governance remained unclear and

subject to interpretation. This reliance on religious identity for Ihisreliance on religious identity for political legitimacy set a dangerous precedent. The Objectives Resolution of 1949, passed under Prime Minister Liaquat Ali Khan, further entrenched the role of religion in the state's affairs. This resolution, later becoming part of the 1956 constitution, facilitated the use of religion as a tool for political manoeuvring, ultimately leading to the exploitation of people's rights. And also the delay in creating a constitution led to political uncertainty. Without a clear legal and political framework, early governments struggled to establish effective governance and a sense of national unity.And the failure to establish a constitution allowed the civil and military bureaucracy to intervene in the political system.

Several key players contributed to Pakistan's state failure like that,the Muslim league leadership inability to establish a clear governing framework and their use of religious identity undermined the foundations of a secular, democratic state. And power vacuum created by the lack of a constitution allowed the military and bureaucracy to dominate the political landscape, stifling democratic development. And empowered by early political decisions, the clergy have wielded significant influence, often at the expense of progressive and inclusive policies. And also the most common reason failure of state isMuslim leadership alliances with feudal elites entrenched patronage politics and hindered social and economic reforms, perpetuating inequality and

underdevelopment. A way forward to built Pakistan as a strong nation,it is essential to recognize the need for a democratic and secular state. A secular state ensures neutrality in matters of religion, allowing individuals the freedom to practice their beliefs without state interference And a democratic and socialist state, which prioritize social welfare and equity. can help create a society where everyone has equal opportunities and access to resources.A secular, democratic framework can help Pakistan move past its identity crisis and build a cohesive national identity that respects and celebrates its diversity. It is through the promotion of shared cultural, linguistic, and value-based commonalities that value-based commonalities that Pakistan can hope to achieve lasting

stability and development.

PIC Orders BISP to Disclose List of Govt. Employees Received **Irregular Cash Transfers**

Soon Times Corresponden Islamabad: The Pakistan Information (PIC) has directed the Benazir Income Support Program (BISP) to publicly disclose the list of government employees, pensioners, and spouses of government employees who irregularly received cash transfers from the BISP program. This directive follows an appeal by citizen Saad Ullah, who exercised his right to information

Information Act, 2017. Saad Ullah's appeal sought a detailed list of a detailed list of government employees and pensioners who irregularly received eash transfers, including their names, grades, and the total disbursed amounts. He also requested similar information regarding the spouses of government employees and pensioners who received cash transfers irregularly.BISP prompting Saad Ullah to file an appeal with the Pakistan Information Commission. In its response to the PIC, BISP argued that the requested information was exempt from disclosure under sections 7 (g) and 16 (g) (ii) of the Right of Access to Information 4. (g) (ii) of the Right of Access to Information Act, 2017. BISP further stated that 140,000 government employees had been excluded from the list of beneficiaries in 2019. However, the Pakistan rejected BISP's plea, asserting that the exemption claimed for those who received BISP allowances through deception was unjustified and contrary to the Act's preamble. The PIC has directed BISP to disclose the names of the irregular beneficiaries as requested by the appellant within 10 days. Failure to comply will result in penal proceedings against the concerned officers of BISP.
