The Election Commission of Pakistan

The Election Commission of Pakistan (ECP) on December 22, 2023 stripped the PTI of its election symbol in view of irregularities in its intra-party polls. The Supreme Court on January 13 upheld the ECP order, foreing the PTI candidates to contest the February 8 general elections as independents.



Today's hearing began with Attomey General Pakistan (AGP) Mansoor Usman Awan presenting his arguments.

Awan told the court that he had received records on reserved seats, dating back to 2002 and 2018.

He highlighted that in 2002, Article 51 governed the allocation of ten non-Muslim reserved seats. In the 2002 National Assembly, after excluding 14 independent members, reserved seats were distributed among two political parties.

Moving to 2018, he noted there were

272 full seats with elections for three postponed and 13 independent candidates elected, nine of whom later joined political parties.

Reserved seats, according to the constitution, are allocated to political constitution, are allocated to political parties based on their election results. The AGP clarified that parties qualify for these seats only if they win at least one seat. Responding to Awan's explanation, Justice Minallah one seat. Political, judicial, and military interventions have been the primary causes of instability in Pakistan, contributing to its tumultuous political landscape. These interventions have repeatedly disrupted the democratic process, undermined civilian governance, and fostered a climate of uncertainty and conflict Political interventions often manifest as power struggles between different political factions, corruption allegations, and the inability of elected Prime Minister to complete their terms Key examples include Benazir Bhutto Dismissed twice from office due to allegations of corruption and mismanagement, her removals were influenced by political rivals and presidential powers. Her terms were marked by internal party conflicts and opposition pressure. Nawaz Sharif Removed multiple times from office, first due to a power struggle with President Ghulam Ishaq Khan, then through a military coup by General Pervez Musharraf, and later disqualified by the Supreme Court on corruption charges. Each removal reflected intense political rivalry and the use of judicial and military means to settle political scores. The judiciary in Pakistan has often been involved in the political process, sometimes acting independently and at other times perceived as being influenced by political or military pressures. Examples include Yousaf Raza Gillani Disqualified by the Supreme Court for contempt after refusing to reopen corruption cases against President Asif Ali Zardari. Most prime ministers have been dismissed or disqualified from holding office. Several others have resigned The first prime minister, Liaquat Ali khan, was assassinated. The remaining prime ministers were designated to carry out a partial term after the office became vacant. The office of prime minister was inaugurated alongside Pakistan independence in 1947. It was

abolished for several years under the country's second constitution, which instituted a presidential system of government. The office was restored in December 1971, at the tail end of the war between West Pakistan and East Pakistan (now Pakistan and Bangladesh, respectively), but it was abrogated later that month. It was reintroduced in 1973 with the promulgation of the country's third constitution. The frequent changes in leadership and the involvement of non-democratic forces in the political process have impeded the development of a stable and mature democracy in Pakistan. The repeated interruptions to civilian rule by military coups and judicial interventions reflect ongoing struggles to establish a robust democratic framework. These challenges highlight the need for institutional reforms and the strengthening of democratic processes to ensure stability, transparency, and accountability in governance. The political history of Pakistan, marked by frequent removals and disqualifications of Prime Ministers, underscores the complexities of governance in a country where political, judicial, and military forces frequently intersect. The US Supreme Court ruled on Monday that Donald Trump cannot be prosecuted for actions that were within his constitutional powers as president in a landmark decision recognising for the first time any form of presidential immunity from prosecution. The justices, in a 6-3 ruling authored by Chief Justice John Roberts, threw out a lower court's decision that had rejected Trump's claim of immunity from federal criminal charges involving for felorts to undo his 2020 election loss to Joe Biden. The six conservative justices were in the majority, while its three liberal members dissented.

Taliban authorities were told women must be included in public life, UN Under-Secretary-General Rosemary DiCarlo said on Monday as she defended a decision to sideline civil society groups at official talks in Doha.
Rights organisations have strongly criticised the controversial UN move to exclude the groups, including women's rights activists, from the two-day meeting on Afghanistan as the price for the Ta i i ban government's participation.
"Authorities will not sit across the table with Afghan civil society in this format, but they have heard very clearly the need to include women and civil society in all aspects of public life", DiCarlo told a Doha newsconference.
The UN-hosted meeting began on Sunday and is the third such gathering to be held in Qatar in a little over a year, but the first o include the Taliban authorities who sexed power

authorities who seized power in Afghanistan for a second

time in 2021.

The talks were due to discuss increasing engagement with Afghanistan and a more coordinated response to the country, including economic issues and counter-narcotics efforts.

The international community has wrestled with its approach to the Taliban since they returned to power, with no country officially recognising its government.

its government. 'Gender apartheid'

Gender apartheid The group has imposed a strict interpretation of Islam, with women subjected to laws characterised by the UN as "genderapartheid". The Taliban refused an invitation to Doha talks in February, insisting on being the only Afghan representatives, to the exclusion of civil society groups. But their condition was accepted in the build-up to this latest round.

Victims of Hamas attack sue Iran, Syria, North Korea in US court

More than 100 victims and relatives of victims of the Oct. 7 attack by Hamas militants in Israel sued Iran, Syria and North Korea on Monday, Towiding Hamas support and demanding at least 34 billion in damages.

The lawsuit filed in federal court in Washington, D.C., by the Anti-Defamation League is the largest case against foreign countries in connection with the attack, and the first backed by a lewish organisation, the ADI. said in a press release.

It accuses the three countries of providing financial, military and tactical support to Hamas. The US government has designed Iran, Syria and North Korea state sponsors of terrorism.

More than 1.200 people were killed in the attack and 250 others were taken hostage, according to Israel; tallies. The plaintiffs in the case include US etilizens injured on Oct. 7, as well as relatives and the estates of victims killed in the attack.

of victims killed in the attack. Israel's offensive in Gaza in response has killed nearly 38,000 people, according to Gazan health officials, and left the enclave in ruins. "Iran is the world's leading state sponsor of antisemitism and terror along with Syria and North Korea, they must be held responsible for their roles in the largest antisemitic attack since the Holocaust," ADL Chief Executive Jonathan Greenblatts sid in a statement.
